President's Report

We are fast approaching the "Election Period" window for active Post-'97 employees that hired prior to November 1st, 2021. This period is when you will have the opportunity to choose either the TraditionalPlus or ChoicePlus Retirement Fund option. Within the next few weeks those of you that need to make a choice between retirement funds will begin to receive information via mail. These mailings will contain information about the two options, important dates, such as the Election Period Window (April 18 – May 13, 2022) and contact information to schedule face-to-face meetings with advisors from Aon, as well as a contact number for their call center. Please utilize these resources so you can make the most informed decision on what fund is best for you. If you have a personal financial advisor, I suggest discussing the options with them, also. Don't hesitate to call me at the Union Hall with any questions either. I can give you as much information as I can about the aspects of each fund, but I can't make the choice for you. There are also QR codes posted throughout the factories that will take you to the link for the calculators for each fund.
