President's Report

The timeline for the retirement fund election (TraditionalPlus or ChoicePlus) for Active Post - '97 employees hired prior to November 1st, 2021, has been set.

March 28th - Postcard mailers will be sent to employees needing to make an election. This postcard will contain key dates that will occur leading up to and during the election period window. It will also be a notification to keep an eye out for your participant kit coming in the mail.

April 4th - The participant kits will be mailed. These kits will contain member specific information on how both retirement plans could affect your retirement savings going forward. It will have comparisons between both plans at specific ages and projections of benefit levels at each phase. It will also contain an explanation on how to make your election and the election form. Your election can be made 1 of 3 ways, mailing the form to Election Service Center, faxing it to the Election Service Center or uploading it to the website. A confirmation statement will be sent to all participants. The kit will also contain information on the resources that will be available to assist you in your decision making. As well as information about a scheduling tool to sign up for a face-to-face meeting with an AON advisor.

April 11th - The call center and website will go live for members to utilize as tools to gather further information on each plan and how it may look at different ages as they close in on retirement. The call center hours will be 11a.m. to 7p.m. CST, Monday through Friday.

April 18th - ELECTION WINDOW OPENS!!!

April 25th - 29th - AON advisors will be available for face-to-face meetings with members. There will be a limit of 600 face-to-face meetings for all 4 Locals in the Quad Cities. If you want to have a face-to-face meeting, please sign up as soon as you receive the packet by using the scheduling tool. These meetings will be held at Stoney Creek Convention Center in Moline. The meetings will be limited to 15-minutes occurring 11a.m. to 7p.m., Monday through Friday of this week. As an alternative, there will be no time limitations on calls made to the call center.

May 6th - Any eligible member who has not made an election by this point will receive a reminder voice message to do so.

May 13th - ELECTION WINDOW CLOSES!!!

May 27th - The website and call center shut down.

June 1st - Election choices officially take effect.

I strongly encourage you to speak with your personal financial advisors if you have one. The advisors from AON will only provide information about the retirement options. They **cannot** give you financial advice. As always, if any of you have any questions about the retirement options or the election process feel free to contact me at the Union Hall.
