The 2023 UAW Stellantis Negotiators for the upcoming 2023 National Negotiations between the UAW and Stellantis were elected by the UAW Stellantis Council Delegates on October 12, 2022. Since the initial election, there have been changes to the negotiation team as a result of local elections.
