V-CAP IS THE UAW'S POLITICAL ACTION PROGRAM
WHICH INCLUDES THE UNION'S PAC (POLITICAL
ACTION COMMITTEE). THE PAC FUND IS MADE UP OF
VOLUNTARY CONTRIBUTIONS FROM UAW
MEMBERS, BOTH ACTIVE AND RETIRED. THE MONEY
IS USED TO SUPPORT PRO-WORKER POLITICAL
CANDIDATES WHO HAVE EARNED THE
ENDORSEMENT OF THE UAW COMMUNITY ACTION
PROGRAM (UAW CAP).

FEDERAL AND MANY STATE ELECTION LAWS PROHIBIT UNIONS FROM CONTRIBUTING MEMBERS' DUES MONEY TO POLITICAL CANDIDATES. THE ONLY MONEY THAT CAN BE USED FOR CONTRIBUTIONS TO CANDIDATES IS MONEY MEMBERS VOLUNTARILY CONTRIBUTE TO V-CAP.
