Reimbursement Guidelines

- Per diem will be paid at the following rates:

 - Monday, January 22, 2024 \$43 (Breakfast provided)
 - Tuesday, January 23, 2024 \$14 (Breakfast and Reception provided)
 - Wednesday, January 24, 2024 \$41 (Lunch provided)
 - o Thursday, January 25, 2024 \$25 (Travel day)

NVAC members will receive car allowance in the amount of \$18.13 per day.

NVAC members that are driving will be reimbursed for fuel expenses. **All receipts must be turned in with the reimbursement form to be reimbursed**. (Scanned copies are acceptable). Mileage is not reimbursable by the International Union, UAW.

Retired NVAC members will be paid the retiree rate of \$65.00 per day.

Active NVAC members will be paid an International rate of pay at \$379.05 per day.
