# President's Report

I have recently had some questions about Endocrine Associates of the Quad Cities and their network status after the merger with Genesis Health Systems. In speaking with the Company liaison for our healthcare coverage, it was determined that Endocrine Associates will remain an in-network facility for Premier plan members. Please keep in mind that any admissions to the hospital from them would still need to be with an in-network facility. Genesis Health Systems is not in-network, other than the hospital in Aledo, IL. It's always a good idea to contact UnitedHealthcare by calling the number on the back of your insurance card to confirm if a provider is in-network or not. If you have any questions about this, please contact me at the Union Hall.

Also, I have been made aware that any retired members in the North Carolina/South Carolina area using providers within Prisma Health may need to find new providers. There is an apparent dispute between UnitedHealthcare and Prisma Health when it comes to the contracted amounts paid to the providers and Prisma Health is no longer part of the UnitedHealthcare Choice Plus network and they are not accepting the UnitedHealthcare Medicare Advantage Plan, either. Please contact UnitedHealthcare to get assistance with finding a new provider that is part of the network. If you have any questions about this, please contact me at the Union Hall.

Just a reminder on "Prior Authorizations" and "GAP Exceptions". A "Prior Authorization" is the approval from UnitedHealthcare of a specific procedure(s). This means the procedure(s) will be covered by UnitedHealthcare as an in-network procedure. A "Prior Authorization" can be granted for an in-network facility or out-of-network facility. It is the members responsibility to make sure the facility and the doctor performing the procedure will also be covered by UnitedHealthcare. A "GAP Exception" would come in to play when a member is seeking to have a procedure or visit with a doctor or facility that is considered out-of-network. The member and their doctor would need to go through the process of applying for a "GAP Exception". UnitedHealthcare would typically check the network of doctors and facilities under our coverage to see if it is something that can be addressed with an in-network doctor or facility first. They will also check to see if the procedure(s) being requested are clinically proven and FDA approved or if they are still in the experimental or trial stage. This is where the doctor requesting the "GAP Exception" would need to give as much detailed information as possible on why the service being requested is medically necessary. As always, it is the members responsibility to make sure any service they are having is covered at the in-network level by contacting UnitedHealthcare at the number on the back of the insurance card. If you have any questions about either of these feel free to contact me at the Union Hall.


