President's Report

Attention Active & Retired members, Deere has made changes to the John Deere Employee Purchase Plan John Deere equipment. Effective for purchases made on or after January 1st, 2024, the John Deere Purchase Plan is no longer a rebate program. The plan benefit for eligible participants will be applied as a discount at the point of sale by the John Deere dealer. Only purchases of new eligible equipment are covered by the plan. The eligible participant must purchase eligible equipment from a John Deere dealer. Purchases made at mass retailers, such as Lowe's and Home Depot are not eligible for discounts.

Step 1: How to redeem your employee purchase plan discount?

Active members will use work email address, Retirees will need their SAP ID (found on Retiree card or by contacting Deere Direct at 1-888-432-3373), individuals on long-term disability and surviving spouses will be validated by Deere Direct from their name and home address.

Step 2: Apply for an employee purchase plan voucher via John Deere Rewards before visiting your John Deere Dealer by visiting www.JohnDeere.com/EPP. You will need to apply for a separate voucher for each piece of eligible equipment you will be purchasing.

Step 3: Tell your dealer salesperson you have an Employee Purchase Plan voucher. Your Salesperson will look up your voucher in the John Deere Rewards system during your eligible equipment purchase. Your voucher will be reflected as a discount on the purchase order. You can combine your voucher discount with other John Deere Rewards discounts and national offers.

Everyone should have received notification in the mail that the pension portion of our benefits has transitioned to Fidelity as of January 1st, 2024. You can access your benefits by logging into www.netbenefits.com/ deere or by calling 800-354-3427. Fidelity is also who you will need to contact to initiate your retirement now. It can be done by accessing the website or by calling and having a representative assist you. As always, myself or Rob Bern will be available at the Hall to assist you with this, if needed.

Another change that also took place on January 1st, 2024 is that any changes to address, phone number, name or marital status need to be reported to Deere Direct. That applies to all members (active, retired, LTD). The number for Deere Direct is 1-888-432-3373.


