President's Report

UAW News

I'd like to start with some good news on the automakers side of the UAW. The National Labor Relations Board recently certified the results of the election in which Volkswagen employees in Chattanooga, Tennessee voted for representation by the United Auto Workers. After several years of unsuccessful organizing drives and heavy interference by local and state government, our newest Brothers and Sisters in Chattanooga stayed the course and found success with their latest push to organize. Both sides are now focused on collective bargaining and reaching a fair agreement to build world-class automobiles together. Congratulations Volkswagen-Chattanooga!

On a more somber note, the recent organizing drive and vote at Mercedes-Benz in Alabama suffered a setback when the workers voted 56% to 44% to not unionize. This drive was also heavily influenced by local and state government interference. The Alabama State Senate passed a bill (SB 231) in April of this year that would remove tax incentives for any company that voluntarily recognizes a union solely on the basis of signed union organization authorization cards (check-off cards). Any company that voluntarily recognizes a card check-off would be required to repay any economic incentives received from the State. This would put a larger focus on union-busting by the companies, something that is already prevalent in the South. Similar legislation has been passed in Georgia and Tennessee. As former UAW International President Walter Reuther said, "There's a direct relationship between the ballot box and the bread box, and what the union fights for and wins at the bargaining table can be taken away in the legislative halls."

Local News

With the downturn in the agricultural and construction markets, we're starting to feel the effects at Deere. Local 434 indefinitely laid-off 34 members on May 31st due to a reduction in orders at Cylinder Division. We are still awaiting the numbers for the Early Order Program at Seeding Group to determine what the upcoming build season will look like. In light of the low numbers for the Early Order Programs for Sprayers and Air Seeders, Seeding Group has decided to layoff another 127 members on June 28th.

Chain-wide, within Locals under the Deere Master Agreement there have been a series of layoffs due to low orders and work being outsourced to Mexico. Waterloo has had 2 rounds of layoffs effecting a total of 500 members. Des Moines Works has laid-off 150 members and Ottumwa Works has indefinitely laid-off 29 members as well as implemented the Voluntary Termination of Employment Program, which 103 members chose to accept. Coffeyville Works also indefinitely laid-off 15 members this year. Harvester Works announced another round of layoffs, effective the end of August, bringing their total to approximately 400 members laid off. Davenport Works also announced layoffs of just over 200 that will take place at the end of August, as well.

Please keep all of these Brothers and Sisters in your thoughts as we work through this difficult time.


