The above UAW officers or their designated representatives are invited to the Missouri Joint Legislative Conference March 24 – 27, 2025 at the Courtyard Jefferson City, 610 Bolivar St., Jefferson City, MO 65101; (573) 761-1400. This conference will have delegates from the UAW, Steelworkers, Machinists, Communication Workers, Transport Workers, and Food & Commercial Workers. Registration will be **Monday, March 24th from 1 - 5:00 p.m. outside of Meeting Room A/B.**

The purpose of this conference is for the mentioned unions to come together in unity and discuss our unions' legislative role in the state of Missouri. **The conference will begin at 9:00 a.m. Tuesday morning in Meeting Room A/B.** Tuesday afternoon and Wednesday morning the conference delegates will go to the State Capitol building to lobby and/or visit with members of the Missouri Legislature to discuss the needs of working men and women in the State of Missouri. **There will be a legislative reception from 6 - 8:00 pm in Meeting Room A/B on Wednesday, March 26th.**

For those delegates needing overnight lodging, arrangements have been made for a limited block of reserved rooms at the Courtyard Jefferson City. Room rates are \$141 (plus tax) per night for a single/double or \$191 (plus tax) for a king suite. **For reservations, call the Courtyard Jefferson City at (573) 761-1400 or 1-800-321-2211 by February 25th.** **When making reservations, you must request a room under the name of "Missouri State Legislative Conference", Group Code: MSL.**

Delegates will receive lost time and expenses through their local union. The local unions and/or retiree councils will not be reimbursed for the State CAP Council Officers who attend the Legislative Conference.

Each local union should send a \$100 registration fee payable to the **UAW Region 4 Midwest States CAP Council** for each delegate. Please complete the enclosed delegate list and return to my office no later than **Monday, March 3rd,** so that we can make sure that everyone has a name badge. The organizers of the Joint Legislative Conference will use this information to assign delegates with the appropriate lobbying group when they go to the Capitol building to lobby and visit.
