#### Registration

#### **Lost Time and Expenses**

#### **Hotel Accommodations**

#### **GUEST ATTENDANCE – New Policy**

Delegates may bring a guest who will share the hotel room reserved by the delegate. However, unfortunately, guests will not be able to participate in any UAW provided receptions or meals.



#### **Airline Reservations**

Attendees are responsible for making their own travel arrangements and they should be made as soon as possible. The cost of the airline reservation is the responsibility of the local union.
