RE: 2018 UAW Voluntary V-CAP Dollar Drive

Brothers and Sisters:

This election may very well decide if we become a "right to work" state or not. Bruce Rauner and his minions are posed to destroy the labor movement and what's left of the middle class if we don't do something to stop them.

One thing we can do is sell V-CAP tickets to raise funds to fight back. We will never be able to compete with the BIG MONEY of our opponents but if we do all that we can to sell V-CAP tickets, we stand a fighting chance.

Enclosed are the V-CAP tickets for your local union. This begins our 2018 V-CAP Voluntary Dollar Drive. The Region 4 Grand Prize for 2018 will be a check in the amount of \$10,000 (less 25% mandatory income tax withholding). There will be a 1<sup>st</sup> prize of \$3,000, 2<sup>nd</sup> prize of \$2,000 and a 3<sup>rd</sup> prize of \$1,000.

The price of V-CAP tickets remains at two (\$2.00) each. Those members on V-CAP check-off will have one ticket printed for each (\$2.00) that they contribute, which will be entered into the Grand Prize drawing along with three (3) additional cash prizes. It is very important that all Local and Area CAP drawings take place prior to September 17, 2018 which is the deadline to return ticket stubs and monies to the Region 4 office.

Please carefully read the contents of this letter and the attached forms. Pay special attention to the bulletin board language that must be included on any prize listing that the local union uses to advertise the prize drawing.

### FORM #1 (YELLOW)

The local union Financial Secretary, upon receipt of the 2018 V-CAP Dollar Drive ticket books, should sign this form as a verification of receipt of the ticket books. The signed form should be returned to Tony Garcia – Illinois State CAP Coordinator – Region 4 UAW, 680 Barclay Blvd., Lincolnshire, IL 60069. Retain a copy for your local union records.

### FORM #2 (BLUE)

This form should be used by the local union to record all information as to the ticket books that are distributed and the monies that are collected.

The Financial Secretary of the local union should forward the original to Tony Garcia - Illinois State CAP Coordinator – Region 4 UAW, 680 Barclay Blvd., Lincolnshire, IL 60069. Keep a copy of this completed form for file records.

**FORM #3 (GREEN)**

For all monies collected, make checks payable to "**UAW V-CAP**". Send these checks, along with the completed green form, to Tony Garcia – Illinois CAP Coordinator – Region 4 UAW, 680 Barclay Blvd., Lincolnshire, IL 60069. The local union should keep a copy of this completed form on file also.

**FORM #4 (WHITE – ACTIVE V-CAP TICKET SALES DRIVE)**

This form was implemented to comply with Federal Election Committee rules and regulations changes which went into effect in 2003. The information requested on this form **must** be filled out entirely for any active member who purchases **\$25** or more in tickets, and any retired member who purchases **\$100** or more. If an active or retired member purchases additional tickets on more than one occasion and reaches the **\$25** active or **\$100** retiree threshold, this information should also be added to this form. **These completed forms must be sent in along with the green form and the check that goes with the green form to: Tony Garcia – Illinois State CAP Coordinator – Region 4 UAW, 680 Barclay Blvd., Lincolnshire, IL 60069. Retain a copy for your local union records.**

**All tickets and stubs, both sold and unsold, and monies must be returned to the Region 4 office by Monday, September 17, 2018.**

The monies that are collected from the sale of V-CAP tickets should be deposited into the bank account of the local union, entered into the local union financial records, and then a check should be made payable to "**UAW V-CAP**" and sent to the Region 4 office. **NO MONEY ORDERS, CASHIERS CHECKS, OR CASH WILL BE ACCEPTED FROM ANY LOCAL UNION.**

If a local union publicizes a prize list in conjunction with the 2018 Region 4 UAW V-CAP Dollar Drive, the following paragraph **must** appear at the bottom of the notice:

**UAW V-CAP is an independent political committee, created by the UAW. This committee does not ask for or accept authorization from any candidate, and no candidate is responsible for its activities. UAW V-CAP uses the money it receives to make political contributions and expenditures in connection with federal, state and local elections. Contributions to UAW V-CAP are purely voluntary and are not a condition of membership in the Union or of employment with the Company. Members have the right to refuse to contribute without fear of reprisal. All UAW members may be eligible for V-CAP raffle drawings regardless of whether they make a contribution to UAW V-CAP. Monies contributed to UAW V-CAP constitute a voluntary contribution to a joint fundraising effort by the UAW and the AFL-CIO.**


**Contributions or gifts to UAW V-CAP are not deductible as charitable contributions for federal tax purposes.**

The above language is provided to meet the requirements that we affirmatively inform the donor that the contribution is voluntary and is used for political purposes.

**ANY PERSON WHOSE NAME IS DRAWN AS A PRIZE WINNER IS PERSONALLY RESPONSIBLE FOR ALL FEDERAL AND STATE INCOME TAXES, AS WELL AS ANY OTHER PERTINENT TAXES.**
