To All UAW Local Union Officers:

As you are aware, the vote count for the 2022 UAW International Officer Election (“Election”) recently concluded. Because no candidate received a majority of the votes in the races for International President, International Vice President (one of three positions), and Region 9 Director, there will be a run-off election for these three races commencing immediately (the “2023 UAW International Officer Run-Off Election” or “Run-Off Election”). The Monitor and the UAW are working together to ensure that all eligible members are able to vote in the Run-Off Election, and as part of that process, **we need your assistance. Specifically, we are again asking that you update the LUIS database to include the current contact information and voter eligibility status for your membership and provide notice of the Run-Off Election to your membership.** Please read this entire email for additional instructions and important deadlines.

### **Election Results**

The unofficial Election results have been posted to the Monitor’s website ([www.uawmonitor.com](http://www.uawmonitor.com)), the UAW website ([www.uaw.org](http://www.uaw.org)), the Election Vendor’s website ([www.uawvote.com](http://www.uawvote.com)), and filed with the District Court for the Eastern District of Michigan.

### **Run-Off Election**

Rules and details for the Run-Off Election are forthcoming, but it is anticipated that ballots for the Run-Off Election will be mailed to members starting on **January 12, 2023**, the deadline for the return of those ballots will be **February 28, 2023**, and the vote count will commence on **March 1, 2023**. Additional information regarding ballots for the Run-Off Election will be posted soon on the Monitor’s website ([www.uawmonitor.com/ballots](http://www.uawmonitor.com/ballots)).

The UAW’s Election Vendor, **Merriman River Group** (“MRG”), will again manage the distribution, collection, and tabulation of ballots, and will facilitate all campaign mailings (postal or email) from the Candidates using the UAW’s Global Mailing List. As with the Election, if you see the MRG name on mail or email correspondence, please be advised that they are contacting you in connection with the Run-Off Election.

### **Eligibility Deadline**

All UAW members in good standing as of **5 p.m. ET on January 31, 2023**, including members who are part time workers, reinstated members, and retired members, will be permitted to vote in this Run-Off Election.

### **Updating and Confirming Member Information in LUIS**

To facilitate the enfranchisement of all UAW members in good standing, it is critical that LUIS contains

up-to-date mailing and email addresses for all UAW members, as well as accurate information regarding the voter eligibility status of each member. **It is the responsibility of the Local Unions to make sure that its members' addresses and eligibility status are updated and accurate on the LUIS system immediately.**

**Specifically**, we ask that you:

1. Strongly encourage the membership of your Local Union to provide updated mailing and e-mail address information to the Local **as soon as possible**.
2. Confirm that LUIS contains new or updated mailing and/or e-mail address information for all active and retired UAW members immediately, but **no later** than **December 16, 2022**, when the membership data will be transferred to MRG for the preparation of ballot envelopes.

In addition, we would remind you that the voter eligibility status of each member as of the **January 31, 2023** eligibility deadline must be accurate in the LUIS database for their votes to count. We would ask that you ensure that any changes on status as of **January 31, 2023**, be immediately reflected on LUIS.

3. **E-mail the Notice** to all members of your Local Union with the email addresses you have on file.
