#### REGISTRATION – Electronically through LUIS

There will be a conference registration (LUIS) fee of \$50 for each delegate. The registration fee for each spouse or companion attending the Monday evening reception is \$50. You can register and pay through LUIS. If you do not use LUIS, please make checks payable to the International Union, UAW. There will be no payment by the International Union for hotel, transportation, expenses, or lost time. #### HOTEL ARRANGEMENTS

DEADLINE: March 19, 2022

Hotel Reservation deadline is March 19, 2022, and conference attendees are responsible for making their own hotel and travel arrangements. Rooms have been secured at a discount rate of \$129 per night, for single or double occupancy. Each additional person will be charged at a rate of \$30 per person, per night with a maximum of four (4) people per guestroom. Rates are subject to applicable resort fee and government room taxes.

A daily resort fee of \$45 plus tax per room, per night plus occupancy room tax will be charged in addition to the room rates. In-room Internet access includes two (2) devices per room, per day. Taxes are subjected to change without notice.

Delegates should identify themselves as attending the "UAW CS/IPS Conference 2022" to obtain the UAW rate. The first night's room and tax deposit are required which can be guaranteed with a credit card.



### **FLIGHTS**

When making your travel arrangements, please allot adequate time for arrival and transportation to the hotel.

Attendees are responsible for making their own travel arrangements and the cost of the airline reservation and agency fee is the responsibility of the local union. Arrangements for booking airline reservations have been made with Travel Solutions International (TSI USA). TSI USA requires a one-time registration for each local union agreeing to their services. Please allow 24 hours for TSI USA to process the information provided. Once that step is complete, you may phone TSI USA on (214)-915-9296, or you may email at **uaw@tsiusa.com**. The transaction fee for making airline reservations is \$20.



#### **GROUND TRANSPORTATION**

SuperShuttle can be used for ground transportation. To make sure you are not waiting at the airport, book your reservation online at <a href="https://www.supershuttle.com">www.supershuttle.com</a>.

#### For Airport Pickup to Hotel:

If you land in Terminal 1: After collecting your luggage, exit baggage claim area via DOOR 8. You will need to board the Shuttle for ROUTE B which includes the Caesars Palace stop.

If you land in Terminal 3: After collecting your luggage, exit the baggage claim area via DOOR 51. You will need to board the Shuttle for ROUTE B which includes the Caesars Palace stop.

#### For Hotel Pickup/Return to the Airport:

Call (702) 382-0342. You should schedule a pickup 24 hours in advance and schedule your ride 3 hours prior to your flight departure. Wait outside of the hotel in the designated shuttle pick-up area.
