The dates for the General Dynamics Conferences are **Sunday, October 21, 2018 through Thursday, October 25, 2018**. The travel days will be **Sunday, October 21, 2018** and **Friday, October 26, 2018**. All participants will be contacting the hotel directly to make room reservations. Also, all travel arrangements are the responsibility of the individual.

### **Registration**

There is a \$40 registration fee for each delegate attending the Council Meeting. A check should be made payable to the "International Union, UAW" and mailed to Attention: Kaitlyn Perry, UAW General Dynamics Department, 8000 E. Jefferson Avenue, Detroit, MI 48214. The monies will then be forwarded to the General Dynamics Council Fund. Registration fees will not be accepted at the Council Meeting.

In accordance with the UAW National General Dynamics Council Bylaws, your Local Union is entitled to the number of delegates as designated on the attached delegate listing.

Registration will be on Sunday, October 21, 2018 from 4:00 – 6:00 PM and on Monday, October 22, 2018 from 7:30 – 9:00 AM.

An agenda will be passed out at registration.

### **Hotel and Parking Accommodations**

A block of rooms has been set aside at the Sirata Beach Resort. The room rate is **\$129 plus 13% tax** per night occupancy each day. For your information, the hotel will waive the resort fee. **Local Unions must call in their reservations by Friday, October 5, 2018 to guarantee this rate.** To ensure receiving the special rate, delegates must identify themselves as attendees of the UAW Agricultural Implement Council, General Dynamics Council and BET Council Group.

There is complimentary self-parking for one car per room.

Day visitor parking will be discounted to \$5.00 per car, per day. Day visitor parking is based on availability.
