### **Hotel and parking accommodations**

A block of rooms has been set aside at the Sheraton Pittsburgh Hotel at Station Square. The room rate is \$109 plus 14% tax, for a single or double occupancy. Local Unions must call in their reservation **by Tuesday, May 4, 2018** to guarantee this rate. To ensure receiving the special rate, delegates must identify themselves as attendees of the UAW General Dynamics Council Meeting.

### **Cancellation of Rooms**

A cancellation less than 72 hours prior to arrival will result in a charge equal to one night's room and tax. Early departures and no-shows will result in the same charge and consequence. (Please get a cancellation number.)

### **Flights**

Attendees are responsible for making their own travel arrangements; the cost of the airline reservation is the responsibility of the Local Union. The transaction fee for emailed reservations is \$10 and the transaction fee for telephone reservations is \$20.


