Registration

Early registration will take place at the Miramar Foyer Registration Booth on Sunday, March 17, 2024, from 2 to 5 p.m. Registration will continue Monday, March 18, 2024, from 7 to 8 a.m. Name badges will be provided to those who pre-registered.

Lost Time and Expenses

All expenses, including hotel and airfare, and lost time wages are the responsibility of each local union. All other expenses to this event (baggage, parking, meals) are the responsibility of the delegate attending the event, and they should follow normal reimbursement processes provided to them by their local bylaws.

Hotel Accommodations

Hotel reservations are the responsibility of the delegates or their local unions. We have arranged a special room rate of \$289 per night. Room rates are subject to applicable state and local taxes (currently \$35.00 Destination Fee plus 11% Government Tax) in effect at the time of check-out. Destination fee will show as part of the rate when making the reservation. Porterage gratuities will be at \$6 per person round trip, and housekeeping gratuities are \$2 per person per room per day plus applicable taxes currently 11.5% will be charged to each guest folio.

Rooms MUST be booked on or before Saturday, February 17, 2024.

To make reservations, please call (787) 993-3500 and identify yourself as attending the UAW National Stellantis Council Meeting. All reservations must be accompanied by a first night room deposit with a major credit card.

Check-in time is 4 p.m. Check-out time is 11 a.m.

Airline Reservations

Attendees are responsible for making their own travel arrangements and should be made as soon as possible. The cost of the airline reservation is the responsibility of the local union.

Arrangements for booking airline reservations have been made with Travel Solutions International (TSI USA). TSI-USA requires a one-time registration fee for each local union agreeing to their services. Delegates who are attending should plan to arrive on Sunday, March 17, 2024, and are expected to depart on Friday, March 22, 2024.


Transportation
