## **ARTICLE I**

# **Current Language**

10. Each General Motors Local Union and/or General Motors Unit shall pay a monthly per capita of 1.5 percent of the current assembler wage rate per dues paying member, and such payment shall be sent to the Secretary-Treasurer of the International Union.

# Proposed Language

10. Each General Motors Local Union and/or General Motors Unit shall pay a monthly per capita of 3.5 percent of the current assembler wage rate per dues paying member, and such payment shall be sent to the Secretary-Treasurer of the International Union.
