

## 37<sup>th</sup> Constitutional Convention Delegates Notice of Nominations and Elections

Nominations and Elections will be taken for Delegates to the UAW 37<sup>th</sup> Constitutional Convention, which will be held June 11-14, 2018 in Detroit, Michigan.

Anyone who has been a member in good standing for 12 months immediately preceding the first day of the month in which the Convention is held (in this case June 1<sup>st</sup> 2018) and a member in good standing of this Local Union for 3 months immediately preceding the first day of the month in which the Convention is held (in this case March 1<sup>st</sup> 2018) is eligible to run as a Delegate.

Those nominated and not present at these meetings will have three (3) working days to accept in writing to a member of their Election Committee or at the UAW Office.

The two (2) top vote-getters of each Election will serve as Delegates. The next two (2) top vote-getters will serve as 1<sup>st</sup> and 2<sup>nd</sup> Alternates in the event the Delegates cannot attend.

With proper notice the Election Polling Times will be extended if overtime is scheduled.
