The Region 4 Retired Workers Fund will pay for your single or double lodging for the nights of October 11th and October 12th. <u>Please call Tamara at (815) 433-2500 for a room reservation no</u> <u>later than Friday, September 24, 2021.</u>

<u>Attention all Invitees:</u> Please report to the PGC Hotel to be notified of your room assignment. We will fill the Pat Greathouse Center Hotel before assigning *anyone* to other area hotels. If there is a need to utilize outside lodging, officers may be housed at the Super 8 – Ottawa or other area hotel. Rooms will be assigned on a first-come-first-serve basis. *Single delegates may be expected to share a room with another single delegate.*

The Region 4 Retired Workers Fund will pay for:

- 1. Single or double room lodging for two (2) nights October 11th and October 12th.
- 2. Mileage at .50¢ per mile (driver only). Car-pooling is mandatory.

Since the following meals will be provided, there will be **no per diem allowed:**

- Monday, October 11th Dinner
- Tuesday, October 12th Breakfast, Lunch and Dinner

Election Guidelines:

- The following eleven (11) Executive Board Officers will be elected: Chairperson, 1st Vice-Chairperson, 2nd Vice-Chairperson, 3rd Vice-Chairperson, Recording Secretary, Financial Secretary, three (3) trustees, Sergeant-at-Arms and Guide.
- 3. Sixty-four (64) Board Members-at-Large will be elected.
- 4. Three (3) alternates to the Board will be elected.
- 5. Only certified delegates are eligible to vote and be candidates for the Region 4 Retired Workers Council Board.

Please send a list of all elected delegates to me by October 4, 2021, so I can furnish this information to the credentials committee in time for this meeting.

Also, enclosed is a report of all chapters in Region 4 and their retiree totals.

Example: Retiree Chapter 94 has a membership of 2,415. They would be allowed 1 delegate for the local union president, 1 for the chapter and 2 additional delegates for each 1,000 members for a total of 4.

Retiree Chapter 1304 has a membership of 1,504. They would be allowed no delegate for president (closed local), 1 for the chapter and 1 for the additional 1,000 members for a total of 2.

Area Councils can elect 3 delegates each.
