Dear Brothers and Sisters:

Plans and arrangements for the <u>2024 UAW National CAP Conference</u> are now under way. The conference will be held January 21 – 24, 2024 at the Marriott Marquis, 901 Massachusetts Ave., NW Washington, DC 20001.

The National CAP Conference is open to all active and retired members ready to help build a member-centered, member-driven political program. We encourage all attendees to be V-VAP contributors to show their commitment to building our political power. Please note the following is **REQUIRED** as you begin your delegate selection process:

- PARTICIPATION IN THE WORKSHOPS: this is our only occasion to meet nationally and provide information in depth to build our political program during the year.
- <u>LOBBYING ON THE HILL:</u> All attendees must participate. A strong showing on lobby day makes a statement to Congress that our Legislative Department relies on.
- ATTENDANCE THROUGH CLOSE OF CONFERENCE ON WEDNESDAY: the conference closes on Wednesday at 3:00 p.m. We want to continue to attract the best speakers and treat them with respect and UAW hospitality. Therefore, flights should be made after 5:00 p.m. that evening, or preferably the next day.

Delegates attending the CAP Conference have the honor of representing their membership and region at a national meeting. It is also their duty to return to their worksites and share the knowledge gained during their week in Washington. Dues dollars pay for this opportunity, and members deserve nothing less.

As in recent years, the application process for credentials and hotel reservation for the conference is available online only. The application may be completed by the delegate, an officer, or staff of the local. The application must be approved by the regional director. Registration is complete only upon submission of the registration fee. Unlike past years, the UAW will not be able to accommodate members' guests, including spouses, partners, and/or companions. No refunds will be given for cancelled registrations. Local unions or CAP councils, however, may replace delegates (pending approval from regional director). Similarly, a link to reserve a hotel room will be available on the registration website. Deadline for hotel reservations is Wednesday, January 3, 2024, and urge you to comply with the call letter guidelines, review them carefully and take the necessary steps to assure that all information is provided.



HOTEL RESERVATION INFORMATION & REGISTRATION

The 2024 National CAP Conference will be held at the Marriott Marquis in Washington, DC. All attending members must register their hotel rooms at https://book.passkey.com/e/50472389.

All hotel reservations and cancellations are the responsibility of the respective conference attendee. Reservations are made on a first-come, first-served basis.

The UAW-negotiated rate is \$229 per night, plus applicable taxes and fees (the Resort fee has been waived). Hotel check-in time is 4:00 p.m.; check-out is 11:00 a.m.

***Cut-off date for reservations is January 3, 2024. Reservations requested after this date will be accommodated based on hotel availability. Please note one-night's room deposit is required for all reservations.

AIRLINE RESERVATION INFORMATION

UAW member attendees can fly in/out of any of the (3) airports in the Washington, DC Metropolitan areas: Reagan National Airport (DCA) 4.6 miles away, Dulles International Airport (IAD) 28 miles away, or Baltimore-Washington International Thurgood Marshall Airport (BWI) 32 miles away.

Public transportation is very easy to access in Washington, DC. The <u>hotel and conference</u> are close to (2) different metro stops: Mt Vernon Square 7th St / Convention Center (Green & Yellow lines) and Gallery Place / Chinatown (Red line).

Uber/taxis are highly encouraged for members. Parking can be difficult to find and expensive.

LODGING

Conference attendees are responsible for making their own travel arrangements, and the cost of the airline reservation is the responsibility of the local union and/or CAP council. Arrangements can be made through TSI by calling 866-397-0667.

EXPENSE GUIDELINES

FINANCIAL ARRANGEMENTS

Lost time, transportation, hotel costs and the \$325 member registration fee will be paid by participating local unions, CAP councils, outside organizations, and, where appropriate, from retiree regional funds. Eight meals will be provided and should be deducted from any per diems: Sunday dinner, Monday breakfast and lunch, Tuesday breakfast, lunch, and dinner, and Wednesday breakfast and lunch.

Adherence to these financial guidelines will expedite the registration process at the conference and in some cases, prevent issues at the CAP Conference registration desk and be greatly appreciated.

TUESDAY RECEPTION

We encourage you to contact your legislators and invite them to attend the UAW reception on Tuesday, January 23 at 6:30 p.m. The purpose of this event is for UAW members to share an evening with their congressional elected officials and national partner groups and allies.

If a congressperson cannot attend, it is not necessary for them to send aides or staff for representation.

DRESS ATTIRE & COMFY SHOES

Winters in Washington, DC can be cold but are much milder than January weather in the Midwest or Northeast. Temperatures generally range from 30 to 40 F, with frosty mornings and occasional snow, rarely sticks. Down jacket/coat is appropriate, gloves and a warm hat are recommended, and temperatures dip in the evenings.

Dress attire for the National CAP Conference is business casual, wear what you are comfortable in. Members will wear everything from UAW-branded polos, hoodies and some will choose to wear suits to go lobby on the Hill with lawmakers. It's YOUR choice.

Members may want to dress up for the Tuesday political and allies reception—but really, wear what you are comfortable in. Just bring your dancing shoes! (Limited head bobbing allowed.)

Conference hotel may be drafty or heat may be pumped up. Recommend wearing layers to put on or peel off for comfort.

Washington, DC is a walking town. Wear good, comfy shoes, warm socks because you'll end up walking more than you thought you would.

***Only Ask: Please bring RED UAW gear to wear on Wednesday, the final day of the conference.

V-CAP SALES BOOTH
