UAW MEMBERS RATIFY HISTORIC CONTRACTS AT FORD, GM AND STELLANTIS

After the historic Stand Up Strike, UAW members at Ford, General Motors and Stellantis have voted to ratify their new contracts, locking in record gains at the Big Three automakers. Across the three companies, 64% of voting members voted in favor of the agreements.

"The members have spoken. After years of cutbacks, months of our Stand Up campaign, and weeks on the picket line, we have turned the tide for the American autoworker," said UAW President Shawn Fain. "The Stand Up Strike was just the beginning. The UAW is back to setting the standard. Now, we take our strike muscle and our fighting spirit to the rest of the industries we represent, and to millions of non-union workers ready to Stand Up and fight for a better way of life."

The 150,000 UAW autoworkers at the Big Three have won back major provisions that were sacrificed during the Great Recession, from cost-of-living adjustments (COLA), to annual bonuses for retirees, to the elimination of wage tiers.

The agreements include substantial wage increases for all Big Three members, life-changing raises for tens of thousands of members, and tens of billions of dollars in product and investment commitments from the companies. After decades of deindustrialization and working-class decline, the new contracts pave the way for a future of reindustrialization and working-class power. Contract provisions include:

- Raises from at Least 33% to Over 160% Over the life of the agreement, members will see raises of at least 33%, after COLA and compounded wage increases, ranging up to over 160% for some of the lowest-paid workers. Tens of thousands of autoworkers will see immediate raises of over 40% upon ratification.
- **Faster Progression to Top Pay** At all three companies, the union won a three-year wage progression to the top pay rate, down from eight years. This restores the progression in place before the 2011 contract.
- Reopening Belvidere, Reinvesting in America Stellantis agreed to reopen an assembly plant in Belvidere, Ill., it shuttered in February and committed to build a \$3.2 billion battery plant there employing more than a thousand union workers. The company was slated to shed more than 5,000 U.S. hourly jobs when bargaining began. It is now on track to add more than 5,000.
- Blazing the Path to a Just EV Transition The UAW won commitments at all three automakers that will bring thousands of electric vehicle (EV) and battery jobs under the union's national agreements.
- Improvements in Retirement Security for All Active and Retired Members Current retirees will receive annual bonuses for the first time in 15 years, a \$1.25 billion boost in their benefits. That is a billion dollars more than the union won for retirees in the last four contracts combined. At all three companies, workers hired before 2007 won an increase to their pension multiplier for the first time in over 15 years. Though the union did not win back defined benefit pensions for post-2007 hires, the employer contribution to their 401(k)s is massively boosted to 10%, which will more than double many members' annual 401(k) contributions over the life of the contract.

All six agreements – hourly and salaried units at each of the three automakers – were ratified by the membership. The results and relevant materials for the <u>Ford</u>, <u>General Motors</u>, and <u>Stellantis</u> contracts can be found at UAW.org.

Is There a Union Meeting — Who cares?

Far too many local unions are not able to secure a quorum in order to carry out the functions of their membership meetings and fully represent the interests of the members. This problem is serious. Too many members never attended a meeting during their entire career. Below are a few of the reasons for not participating usually heard:

- "I don't have the time." Most meetings are regulated to about 2.5 hours once a month, once a quarter, or some even have them only twice a year. Two and a half hours out of 730 hours in a month is not too much to ask when you consider what is required to occur at a union meeting.
- "If they hold them on a different day I'd go." Most locals have fixed dates for meetings written in their bylaws. The APWU represents multiple crafts and more often than not members work on different tours. An effort should be made to rotate the meetings.
- "All they do is fight." A membership meeting is usually the lawmaking authority in a local. Not the President, not the Executive Board, it is the membership that truly is supposed to ensure the membership is properly represented. There are Rules of Order that are supposed to ensure a democratic and orderly meeting.
- "The meetings are boring!" Most local bylaws have an "Order of Business" with required reports such as that of the President and the all-important Financial Report. Some of the locals have not updated their by-laws and still call unfinished business "old business." However, almost all locals also have "new business" listed. Under this item many issues can be discussed, including what is the current problem important to the rank-and-file members.
- "I don't get how they talk." Too often regular attendees who are used to "parliamentary procedure" get too technical. The purpose of 'Robert's Rules of Order' is to ensure questions are handled democratically. The Chair should not be dictator. The Chair's main function is to get the business done in accordance with the local's constitution and by-laws and protect everyone's right to participate. The rules can be used to try to undermine the will of the members present and the Chair has to prevent that.

How Can We Improve Meetings?

How can a local ensure a sufficient number of members attend their meeting? There is no magic wand, but here are some ideas:

- Welcome new attendees. Explain what happens at the meeting. If time is taken to make the meeting meaningful; they will likely return. Work at helping that member so that they realize meetings work! They will let others know and so interest will grow.
- Give members a sense of power and ownership of their union. We preach that members are union and too often do not include them in enough of the process. Make this an event where they can truly see their elected leaders in action on behalf of every member.
- Spruce up the agenda under new business. If there are controversial issues on the work floor make that a topic of new business. Let them vote on policy positions of the locals. Invite guest speakers.
- Announce the meeting well in advance and follow up with personal contacts with individual members. Don't give up on them if they are a no show. Go back and ask them why they were not able to attend. If possible, rotate the meetings. Space will not permit me to elaborate more but there are hundreds of ideas and projects. Form a committee to work on some.

Next time someone asks "Is there a Union Meeting?" the response is "yes there is, can I pick you up to go together?"
